# **OAK FOREST FIGHT CONTINUES**

For nearly four months, the SF Civic Club has been working fervently on behalf of residents to

stop the opening of the south end of Oak Forest into a proposed residential development by supporting the Variance request of the developer. SFCC representatives have made calls, sent emails, written letters, researched laws, studied plans, attended & testified at hearings, encouraged residents to get involved, and much, much more. A huge THANK YOU goes to each neighbor that has also taken the time to send correspondence, make phone calls, contacted their neighbors, made and distributed flyers, attended hearings, and testified before the Planning Commission. Your efforts are being heard by the Planning Department and Commission and your willingness to help with this fight is appreciated by your neighbors. **BUT TIME IS RUNNING OUT AND WE CANNOT STOP FIGHTING TO KEEP OAK FOREST AS A CLOSED STREET!** 

A recently postponed hearing on the requested Variance will be held on **Thursday, June 23<sup>rd</sup> at 2:30 pm** at the City Hall annex. We still need residents to let their voices be heard before and/or at the hearing to tell the City that we **SUPPORT THE VARIANCE and WANT TO KEEP OAK FOREST STREET CLOSED.** 

#### What can YOU do?

Contact the City Planning Department and let them know that you **SUPPORT THE VARIANCE AND OPPOSE the opening of Oak Forest in ANY MANNER** (Eg: cut through to Loop, cul-de-sac, or pedestrian gate). You and your neighbors can:

## It's Hurricane Season...

If a hurricane hit Houston tomorrow, would <u>you</u> be prepared? The **City of Houston's Office of Emergency Management (OEM)** has the job of preparing the City to respond and recover from emergencies, such as hurricanes. If you are in need of evacuation transportation or have hurricane related questions, the OEM can be reached by calling 713-884-4500. They offer the following Hurricane Preparedness tips:

**HAVE A PLAN** of action for any emergency. If you must relocate, have a predetermined destination, route and alternate route -- whether out of the area or to a shelter.

**LISTEN** to local emergency officials for the latest information, and follow their instructions. Listen to local TV and radio. (KTRH-AM 740 is the designated Emergency Alert Station for the Houston area). Have a battery operated radio with extra batteries on hand.

#### **PREPARE: Have these emergency supplies:**

- \* Non-perishable food items and water in containers (1 gallons of water per person per day).
- \* More than one flashlight and extra batteries.
- \* First-aid kit, along with any prescription medicine.
- \* A full tank of gas in your automobile
- \* Cash if power fails, ATMs may not work
- \* Clothing and hygiene items
- \* Pet necessities including food
- \* Plywood and/or Plastic sheeting
- \* Important papers in a waterproof (Ziploc) bag

### Know the difference between a hurricane WATCH and a hurricane WARNING and TAKE THEM SERIOUSLY!

A hurricane **WATCH** is issued when a hurricane becomes a threat to this coastal area within 36 hours. Everyone should be prepared to act promptly if a hurricane warning or relocation is recommended. A hurricane **WARNING** is issued when hurricane winds of 74 mph or higher, or dangerous seas and flooding, are expected within this area within 24 hours.

### CAN FIRST RESPONDERS FIND YOU IN A CRISIS?

Step out your front door and take a look at your house – what you see or don't see could save your life. Without a visible address showing on your home, life-saving help may be delayed while emergency responders (HPD or

HFD) try to figure out which home is yours. According to Houston City Ordinances, every home should have identifying address



numbers posted within 18 inches of the entrance. Install large reflective numbers (minimum 3 inches) on your house, curb, and/or mailbox so police and other emergency personnel can find your home quickly. These numbers can be purchased at Lowes, Home Depot.....

You may be surprised at how many homes in Shepherd Forest do not have clearly marked addresses on their house or curb. Taking the time to check your home and/or that of a neighbor could make a difference of precious minutes while you wait on emergency responders trying to guess where you live.

**REMODELING OR UPDATING YOUR HOME?** Shepherd Forest Deed Restrictions require residents to submit all building plans to the Architectural Committee for approval BEFORE any work begins.
