#### Join a Committee

Residents actively volunteering is what makes Shepherd Forest a great neighborhood. Consisting of dedicated resident volunteers managing civic club finances, maintaining deed restrictions, planning social events and more. #### **Architectural Committee**

This committee helps homeowners avoid conflicts with deed restrictions by reviewing plans for all construction and renovation that are also submitted to the City of Houston for the permitting process. For more information, consult your section's deed restrictions and the building application form located at <a href="https://www.shepherdforest.org">www.shepherdforest.org</a>.

#### **Beautification Committee**

Beautification projects include judging Yard of the Month, Halloween and Christmas decorating contests, updating neighborhood signage, organizing clean-up events, encouraging neighbors to care for their yards, planting trees in the area, and more.

#### **Deed Restriction Enforcement Committee**

This committee monitors and follows-up on compliance to the SFCC Deed Restrictions and city ordinances. They take input from residents, determine if violations have occurred, and work to get homes in compliance when necessary.

#### **Deed Restriction Revision Committee**

The committee collects notarized signatures from homeowners who wish to adopt the proposed deed restrictions and keeps track of the current names and other pertinent information of those who have signed. If the signatures, the committee will complete the process of changing the original deed restrictions for sections 1 and 2 to the adopted ones.

#### **Membership Committee**

This committee is tasked with increasing participation in the SFCC by managing membership campaigns, conducting surveys, and making sure people are available to accept new members at SFCC events.

#### **Newsletter Committee**

Our monthly newsletter, the *Shepherd Forest Times*, is written, managed, and distributed to the nearly 935 Shepherd Forest homes each month by volunteers, and it is a wonderful communication tool and source of pride for SFCC. Volunteers help write, design, distribute and deliver the newsletters

#### Security/Citizens on Patrol (COP) Committee

The Citizens on Patrol, administered by the Houston Police Department, maintains a presence in the neighborhood that deters criminal activity. This program includes volunteer resident patrollers, the vehicle sticker ID program, and communication with the Houston Police Department and other local law enforcement agencies. #### **Social Committee**

This committee plans SFCC socials, typically at restaurants, on odd-numbered months throughout the year. The committee also helps organize and work at functions, including the Easter Egg Hunt, Annual SFCC Picnic, and the Christmas Party.

#### Website/Social Media Committee

This committee oversees our website, SFCC Facebook page, and NextDoor Shepherd Forest information. They publicize our events and make sure that our website is updated regularly. If you are into technology, this committee may be the right fit for you.

#### **Welcome Committee**

The Welcoming Committee is tasked with welcoming new residents and personally inviting them to become involved. They make welcome packets and distribute them, along with the SFCC handbook, to our new neighbors.



#### **Deed Restrictions**

Shepherd Forest is a deed restricted neighborhood. Deed restrictions protect your investment and protect the character of Shepherd Forest. They ensure that we have uniformity in building codes. All three sections have a separate, yet similar, set of deed restrictions. Sections 1 and 2 currently have the original deed restrictions that were created at the inception of the neighborhood. Section 3 homeowners ratified an updated version of their deed restrictions. While deed restrictions vary by section and each has unique wording, there are common deed restrictions to all sections. Most violations occur when a resident builds or remodels and is not aware of the building setback lines. We encourage you to familiarize yourself with them, but if you have any questions, please feel free to email or call us.

#### **Architectural Review Process**

If you plan to remodel your existing home or build a new home on your lot, the City of Houston requires that you obtain prior approval from your civic club to ensure that your plans will not violate the set deed restrictions of Shepherd Forest. This step allows for a smooth building process and avoids potential lawsuits from the City of Houston Legal Department. The City of Houston wants to ensure that building permits do not violate any of the following provisions of deed restrictions: authorized use of property; no authorization for garage apartment; front setback; side/interior setback; rear setback; side street setback; minimum/maximum lot size; minimum/maximum building size; number or type of structures on a lot; and height of structure on a lot. # **Parking Primer**

As a Civic Club, we hear complaints from residents about all kinds of things. One of the most prevalent issues has been parking, and the way some neighbors park their vehicles in unsafe, and sometimes illegal, places. Here are some common violations, and the City of Houston fines that accompany them.

In driveway parking- We hope all cars are parked in driveways, but this may cause a car to be parked across and block a sidewalk. According to HPD, although your driveway may extend to the sidewalk, the sidewalk is the public right-of-way. A blocked sidewalk may force a pedestrian into the street with their back to the traffic. (\$40 fine)

#### Parking on the street- Key considerations:

- Houston Code of Ordinances Sec. 26-93 that states "A car should not remain parked for more than 24 hours on the public road. This helps to prevent the neighborhood blight created by junked and abandoned cars." (\$30 fine)
- Houston Code of Ordines Sec. 26-85 states: "A driver who stops or parks on a two-way roadway shall do so in the direction of authorized traffic movement with the right-hand wheels of the vehicle parallel to and not more than 18 inches from the right-hand curb or edge of the roadway." (\$40 fine)
- Houston Code of Ordinances Sec. 26-84 states: "No person shall park any vehicle upon a street or alley in such a manner or under such conditions as to leave available less than ten feet of the width of the roadway for free movement of vehicular traffic." (\$40 fine)
  This means to avoid parking such that you block the people across the street from getting out of their driveway.
- Important distances: Fire hydrant- 15 feet (\$105 fine), Crosswalk- 20 feet (\$40 fine), Stop sign or traffic signal- 30 feet (\$40 fine)

**Parking on unimproved surfaces**- Shepherd Forest is also part of the City of Houston's Prohibited Yard Parking program. This means that parking of vehicles on any unimproved surface in the front or side yard within single-family residential areas is prohibited (up to \$150 fine per day).
