UPDATES TO THE SFCC BY-LAWS

The SFCC Board recently approved updates to the current Shepherd Forest Civic Club By-Laws, as submitted by the By-Laws Committee. The revisions were minimal, with most being typographic or grammatical corrections. The proposed By-Laws updates will be discussed and Civic Club members will be asked to approve the updates at the May civic club meeting.

CITIZENS ON PATROL - SECURITY REPORT

This month (and going forward) we are expanding our report to include incidents that have occurred near, but not necessarily within the boundaries of Shepherd Forest. As our Security Task Force has noted, we are not an isolated "territory" and what happens nearby can, and often does, migrate into our neighborhood.

In response to recent requests to more clearly define the terms we use in our report:

THEFT: A person commits theft if they appropriate property with intent to deprive the owner without the owner's consent. e.g. Someone steals your car.

BURGLARY: Entry into a building illegally with the intent to commit a crime, especially theft.

e.g. Someone breaks into your home.

ROBBERY: A person commits robbery if in the course of committing theft they cause bodily injury to another or threatens or place fear of imminent bodily injury or death. e.g. Someone robs you with a knife or gun.

SECURITY TASK FORCE UPDATE

The next meeting of the Security Task Force will be held on Thursday, April 19, 7:00 p.m., in the library of Garden Oaks Montessori Magnet School, located at 901 Sue Barnett.

During the meeting we will discuss next steps, including who else to invite for presentations, cost of programs, and how to get feedback from residents/owners about whether or not they would be willing to pay for a security service. We will also brainstorm fundraising ideas/activities. Previous suggestions have included partnering with other subdivisions, partnering with local businesses, wine walk, casino trip, silent auction, lawn signs for SF contributors, community garage sales, and applying for available grants. If we decide to proceed with any of these ideas, we would need to determine who would be responsible for organizing them. Preliminary recommendations from this meeting will be presented to the SFCC board in April. Looking forward to seeing you at the meeting!

HOME SALES ARE HEATING UP IN SHEPHERD FOREST THIS YEAR

Spring is here, and summer right around the corner, but the real estate market has already heated up. Here in Shepherd Forest, we've started the year off by selling 28% more homes in the first quarter than we did in Q1 2017, and more than twice what we sold in Q1 of 2016.




