## UPDATED CIVIC CLUB BY LAWS NEAR APPROVAL

SFCC BOARD OF DIRECTORS SEEKING FINAL PUSH TO APPROVE AMENDED BY LAWS

Almost a year ago, a committee was formed to review and revise the current Shepherd Forest Bylaws. The committee made update recommendations at the May Board of Directors meeting, and revisions were presented to the Civic Club at the May General Meeting.

Updates to the bylaws require a majority vote by the Shepherd Forest Civic Club dues-paying members, with one vote per household. You've probably seen the flyers in your Newsletters over the summer and the Membership Survey in November also included a place to check off your approval. As we go to press, we only need 20 more votes to complete this process.

Please take a few minutes to submit your approval. Of course we will accept your annual dues and vote at the January General Meeting. Captain Dan Harris of the HPD North Patrol Division will cover concerns related to homeless individuals living under the Loop 610 and Ella Blvd. underpass, panhandlers along TC Jester Blvd., an uptick in car burglaries, and crimes associated with vagrant activities near the currently vacant Temple Oaks Baptist Church. Don't miss this meeting with Captain Harris as he discusses these issues and answers your questions about these and other crime related topics. ## CONSTABLE SECURITY PROGRAM UPDATE

Shepherd Forest will not participate in the Constable's Security Program in 2019. Less than half of the approximately 200 households required indicated that they would be willing to pay the required \$375 annually to participate.

In recent surveys however, respondents have indicated that Security is among their highest priorities for the Civic Club, so options such as the Citizens on Patrol program will be integral if we are to improve security in our neighborhoods. ## RECYCLING & HEAVY TRASH UPDATE

Many residents have recently reported missed or delayed recycling and heavy trash pickup. This has been a major issue city-wide over the past few months, and City Councilwomen Ellen Cohen recently shared this information on why the delays are happening and what the Solid Waste Department is doing to get us back on schedule.

- Unfortunately, the City of Houston's fleet of automated recycling pickup trucks is aging and many sustained damage during Hurricane Harvey. This has led to hundreds of hours of equipment downtime as the trucks are repaired.
- A nation-wide skilled labor shortage has impacted Houston. The department is in dire need of new truck mechanics and experienced CDL drivers.
- Solid Waste is experiencing the typical increase in volume they see immediately following the holidays.

## WHAT IS THE CITY DOING ABOUT IT?

- This summer the department is scheduled to receive 69 new trucks, which will ease the burden on the existing fleet.
- Although the majority of City of Houston departments remain under a hiring freeze, Mayor Turner has lifted this restriction for Solid Waste. The City of Houston hosted a Job Fair to recruit new workers. To apply, please visit: [www.governmentjobs.com/careers/houston](http://www.governmentjobs.com/careers/houston)
- The department has had existing staff working overtime on week-ends to try to catch up.
- Mayor Turner is asking the department, 311 operators, and Council Members to keep his office apprised of all missed and delayed pickups so that he and his team can personally track them.
- The Solid Waste Department's Facebook page has daily information on what routes are being picked up each day.
- Regularly-scheduled pickups are projected to resume within approximately 60 days.
