REVIVING THE CITIZENS ON PATROL PROGRAM

The Houston Police Department's Citizen Patrol program was established in an effort to bring citizens and HPD together for a common goal – eliminating neighborhood crime. The program is designed to provide a means for citizens to organize into patroller groups and be the additional eyes and ears the police in our neighborhood. Shepherd Forest participated in a previous version of the program for many years, but with participation waning, our program has been dormant for the past couple of years. Recently there has been a surge of interest in reviving the program, and because ours has been deactivated, we will need to start over if we want to participate. This means that even if you have been trained to participate in the past, you will need to attend another training session.

HPD has recently appointed Nicole Carter as the new director of the COP program. She announced that training will now be done on a quarterly basis (4 times per year) and the next training session is Thursday June 20, 6 pm, at the North Command Station located at 9455 W. Montgomery Road. All interested parties must submit an application and consent to a background check by going to https://www.houstontx.gov/police/vip/vip_citzpatrol.htm.

The deadline for submitting applications is June 13, but please do not let this deter you from sending yours in. Another training session will be scheduled in the fall, and more advanced notice will be given on Facebook and here in the Newsletter.

Of course none of this can go forward unless we have a COP Coordinator. In addition to being trained as noted above, the COP Coordinator also collects patrol hours and information from the group, records criminal activity, recruits other patrollers, and completes a few simple forms to be submitted to HPD each month. If you are interested in becoming the COP Coordinator for Shepherd Forest, submit your COP application to HPD by June 13, attend training on June 20, and then contact any Civic Club Officer or Board Member, (listed on the last page of the newsletter) or reach out via e-mail - info@shepherdforest.org - to submit your name.

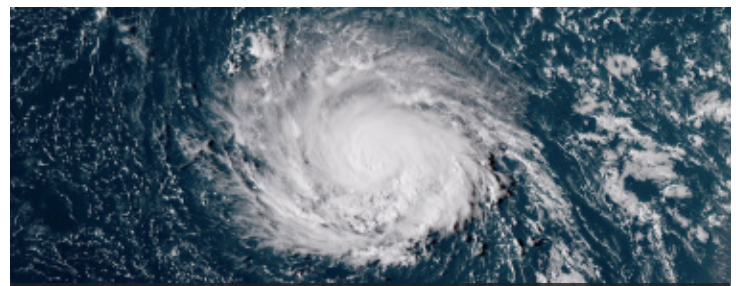

HURRICANE PREPAREDNESS 101

Hurricane season is here again, and the memory of Hurricane Harvey is still fresh in many minds. Here on the Gulf Coast hurricane preparedness is an annual concern, and NOW is the time to make sure you've got everything you might need to survive a storm, and the possibility of losing power for extended periods of time.

PROVISIONS

- Bottled water - one gallon of water per person per day. Keep at least a 3-day supply of water per person. Fill empty spaces in your freezer with bottled water - it will keep food cold longer if you lose power.
- A three-day supply of non-perishable food. Select foods that require no refrigeration.
- A complete first aid kit on hand - bandages, gauze, hydrogen peroxide, non-prescription medications, latex gloves, etc. Refill prescription medications and keep cold packs and a cooler ready to keep medication like insulin cool.
- Phones - be sure you have a cell phone charger for your car. Without power to your home, this will be the only way to keep it operating. If you still have a landline, have a corded phone handy. Your cordless phones won't work without electricity.
- Pet needs - food, water, cat litter, special medication, etc. Have pet carriers ready in case of evacuation, and make sure your pets are wearing collars with current identification.
- Extra paper towels, plastic bags and toilet paper.

IN AND AROUND YOUR HOME

- Security supplies for doors and windows - During Hurricane Ike's approach in 2008, a severe shortage of plywood occurred.
- Have your trees trimmed of dead and dangerous limbs and branches. High winds and driving rain can cause limbs to fall on your house or car, causing significant damage.
- A generous inventory of flashlights, fresh batteries, candles and matches.
- Keep your car filled with gas.
- Have cash on hand - ATMs will not work if power is out
- If you have a generator, be sure you are familiar with its safe usage, and have the fuel you need to run it.
- Tools - have the basics ready and easy to find - a saw for small branches, hammer, pliers, screwdrivers, etc. Have a fresh charge on your power tools.
- Always store important items in plastic tubs instead of cardboard boxes
- Take some time to make a video or photographic inventory of the contents of your home. (This is always a good idea for insurance purposes) If you are forced to evacuate or insurance coverage becomes an issue, that information will be very valuable.
- Check the storm drains near your home, and rake out and remove leaves, tree debris, lawn clippings, etc. that have been piling up.
- Check with your neighbors, and team up to help nearby seniors who may not have the capability to secure their homes on their own.
- Exchange phone numbers and contact information with their families in case they need to be evacuated.

AVENUE ON 34TH – AN UPDATE



As reported previously, Avenue CDC, a non-profit organization dedicated to providing affordable housing for the Houston area, intends to build a 70-unit apartment complex on the 34th Street site where Doyle's Restaurant now sits. At a meeting in May with the Oak Forest HOA, their Executive Director Mary Lawler presented an update on the plans for this complex. After considering the input they received from other neighborhoods at other meetings, they now propose the following:

- The complex will still have 70 units, but would be built with four stories instead of five. Therefore it would have a 20% larger footprint on the property.
- Responding to concerns about access and egress to the property, and to accommodate the enlarged footprint, they plan to also purchase the land contiguous to the original plot, also currently owned by Doyle's, which is accessed on Lou Ellen Street. This will allow for 2 entrances on separate streets.
- A small group of units (14) will be rented at market rate, and will not be part of the government subsidized program.
- The complex will also include a pool and a playground, as well as after-school programs and meeting rooms for community activities.

Lawler also addressed concerns that had been raised regarding tenant qualifications. Avenue runs a criminal background check but not a credit check. "We want to help people repair or improve their credit" she said.

Although the properties are still under contract, as we go to press, they have not yet closed.
