MONEY MATTERS

Are you taking full advantage of your 401(k) plan? Here are 4 major benefits to these plans that are worth your attention.

- 1. Automatic Payroll Deduction. You are much more likely to save money when it's automatically withheld from your paycheck, as opposed to it being up to you.
- **2. The Match.** In 2018, many employers match their employees' 401(k) contributions to some degree. If that's the case for you, try to contribute at least the minimum needed for matching. Otherwise, you're literally leaving free money on the table.
- 3. Stable Value Funds. These funds are typically only available through special arrangements such as a 401(k), and pay interest comparable to a bond fund – but without fluctuating in value. This can be very beneficial if you're looking for better returns than cash, but with less volatility than bonds.
- **4. Access to Loans.** You may be able to borrow from your account while still working? This ends up being advantageous since you don't have to worry about paying taxes, and you can put the money back in your account.

SECURITY TASK FORCE UPDATE

How important is security to the residents of Shepherd Forest? According to the SF Civic Club 2018 survey, 82% marked | "very important," and another 12% checked "important." Based on the survey results, the SF Civic Club board organized a Security Task Force to contact security companies and law enforcement, and we have thus far held meetings with both S.E.A.L. (Strategic Executive & Logistical Security Solutions) and the Precinct One Constable's Office.



HERE ARE HIGHLIGHTS OF THE CONSTABLE'S OFFICE PROGRAM:

- Patrol in Marked Constable Cars
- Ability to Write Tickets and Make Arrests
- Deputy Assigned to Area and Attend SF Meetings
- Vacation Watch Program for Residents in Contract Areas
- Constable Signs Placed Throughout Subdivision

During the meeting, the audience also received a Houston Police Department map of Shepherd Forest, as well as maps for Garden Oaks and Shepherd Park Plaza, two subdivisions where the Constable's Office currently has contracts. According to these maps, Garden Oaks had 1 robbery and 2 thefts within the last 30 days, and Shepherd Park had 1 robbery only, while Shepherd Forest has had 2 thefts, 3 burglaries, and 2 robberies during the same period. In addition, West 34th, Ella, West T.C. Jester, and the 610 Frontage Roads that bound our subdivision had 12 robberies, burglaries, and thefts within that same 30 days.

ALBA SIDEWALK PROJECT HITS A SPEED BUMP

Thank you to the many Section 1 residents who offered support for the Alba Sidewalk Project. As you may recall from one of the previous Newsletter editions, the best option to move ahead with a sidewalk installation project on Alba is to come together as a community and self-fund the project.

Past Presidents, David Hille and Jennifer Woodruff met in January to measure the length of phase one – a sidewalk on Alba from West 31st Street to connect with the current sidewalk that ends just north of Gardendale. That section measures approximately



423 linear feet, and according to city regulations all new sidewalks have to measure 5 feet in width. We shared the project measurements with two contractors and received two bids; one came in at \$36,000 and the other came in at \$16,500. Breaking the lowest bid down, that would require 66 households to contribute \$250 each. Is that feasible? Our residents would have to be the deciding factor.

Another option we may be able to take advantage of was offered by Stomping Ground, a restaurant/entertainment venue breaking ground on 34th street, just west of Alba. They have offered to allow us use of their land - before any improvements begin - to host a fundraiser. Some suggestions included a pop up crawfish boil, BBQ or other food type fundraiser. This option will require upfront expenses like equipment, tables/chairs, tents, food, beverages, utensils, etc.

As you can see there is no quick and easy solution. Our next step is to survey our community to find out which option a majority of residents would support, then form a committee to make this project happen. DO RISING INTEREST RATES = LOWER INTEREST IN BUYING?

After an extended period of record low interest mortgages, we are at last facing the reality of rising interest rates. But, there is no need to panic. Although we are now around 1/2% percent higher than we were on January 1, most experts agree that the interest



rate won't surpass 5% by the end of the year. And while 5% is still historically a good rate, it is motivating many home buyers who have been on the fence to act now. This is reflected in the amount of pending contracts in Shepherd Forest. Currently, we have 15 homes for sale, 7 of which are already under contract. So far this year we have had 4 sales close, which is fairly average for the first two months of the year. One of the sold homes is ready for renovations and another was the first new construction sale in the neighborhood in 2 1/2 years. Next month we'll see the full first quarter 2018 sales and be able to compare those to the same quarter, previous years' sales.
