CREDIT CARD CONCERNS HAVE YOU BEEN SKIMMED?

There has been a recent increase in reported incidents of credit card skimming in the Oak Forest and Shepherd Forest area. Credit card skimming occurs when a device is installed over the slot where you would normally slide your credit card. The skimming device reads and retains your information, allowing thieves to access your cash or credit. The most common place to find these is on a gas pump or a stand-alone ATM where someone could install it without attracting a lot of attention. Along with the skimming device a small camera can often be found installed nearby to record your PIN number, if you're using a debit card. Creative thieves can even install a false keypad over the real one – another easy way to collect your information without a camera.

HOW CAN YOU PROTECT YOURSELF FROM THIS SCAM?

Whenever you use your credit or debit card at a self-serve machine, look carefully before sliding your card. If the device seems not to be part of the original equipment – a different color, bigger than it needs to be, feels loose or doesn't conform to the readers on other nearby machines - DON'T USE IT. Cover your hand while you are entering your PIN number. Thieves like to install skimmers on machines that are out of the way, so as not to attract attention. If you must use an ATM, choose one that is in a high-traffic area or one at your bank. (Bank ATMs are monitored by video cameras that discourage this type of activity but are still vulnerable.) Check your bank and credit card accounts frequently. If your credit card company offers Fraud Protection, consider opting into this low-fee feature. They will let you know if there has been suspicious activity on your account. Several major gas companies also offer an app which allows you to pay via your cell phone.

If you don't notice a card skimmer but your card data is stolen, take heart. As long as you report the theft to your card issuer or bank as soon as possible, you will not be held liable for the lost amount and your money will be returned.
