** This attempted theft was fortunately foiled by an alert SF resident who had noticed a suspicious person digging through trash that was set on the curb. Minutes later, she spotted him disconnecting a large AC unit on the side of a neighbor's home. When she spoke to him, he left, but not before another neighbor managed to snap a photo of his vehicle. Through the resident's description and photo, HPD was able to link the suspect to at least two other burglaries in Section Two of Shepherd Forest! Many thanks to these brave residents for taking the time to "get involved" and help STOP crime from happening in our neighborhood.

DON'T MISS THE SOLAR ECLIPSE!

Next month, on April 8th, a rare event called the "Great North American Solar Eclipse" will occur. The total solar eclipsewhere the shadow of the moon will plunge a narrow strip of land into darkness in the middle of the day — is an astronomical experience like no other that will be unusually accessible to millions of people. The duration of totality will be up to 4 minutes and 27 seconds, almost double that of The Great American Eclipse of August 21, 2017. The 2017 total solar eclipse was witnessed by about 20 million people in the USA and the upcoming 2024 Great North American Eclipse is expected to be witnessed by 32 million living across the USA.



When watching the partial phases of the solar eclipse directly with your eyes, which happens before and after totality, **you must look through safe solar viewing glasses** ("eclipse glasses") or a safe handheld solar viewer at all times. Eclipse glasses are NOT regular sunglasses; regular sunglasses, no matter how dark, are not safe for viewing the Sun. Solar viewing glasses can be found in stores and are also available for sale online. Always inspect your eclipse glasses or handheld viewer before use; if torn, scratched, or otherwise damaged, discard the device. Always supervise children using solar viewers. Do NOT look at the Sun through a camera lens, telescope, binoculars, or

any other optical device while wearing eclipse glasses or using a handheld solar viewer — the concentrated solar rays will burn through the filter and cause serious injury to your eyes.

The next visible total solar eclipse to cross over the U.S. after April will come in more than two decades on Aug. 23, 2044, according to NASA. A total solar eclipse is also far more impressive than a lunar or an annular solar eclipse. During an annular eclipse, the moon covers the Sun but leaves an outside ring some call a "ring of fire" — it darkens the sky instead of plunging Earth into a night-like darkness, which is what happens during a total solar eclipse. And a lunar eclipse – the appearance of a red moon – happens when the moon passes into the Earth's shadow. IT'S A MATTER OF LIFE AND DEATH...

Take just a minute to step out your front door and take a look at your house – what you see or don't see could save your life. Without a visible address showing on your home, life-saving help may be delayed while emergency



responders (HPD or HFD) try to figure out which home is yours. According to Houston City Ordinances, every home

should have identifying address numbers posted within 18 inches of the entrance. Install large reflective numbers (minimum 3 inches) on your house, curb, and/or mailbox so police and other emergency personnel can find your home quickly. These numbers can be purchased at Lowes, Home Depot..... You may be surprised at how many homes in Shepherd Forest do not have clearly marked addresses on their house or curb. Taking the time to check your home and/or that of a neighbor could make a difference of precious minutes while you wait on emergency responders trying to guess where you live.
