CENTERPOINT TO ADDRESS RESIDENTS TREE CONCERNS

Shepherd Forest residents have recently expressed their outrage with the progressive removal of trees by CenterPoint on the easement east of Ella Blvd, with no notification to those affected. Concerns expressed by residents include the potential impact on quality of life, destruction of wildlife habitat, the loss of green space and natural sound barrier, light pollution, visual blight, and decreased property values. In addition, the tall flood lights facing south toward Stonecrest that were installed in the easement west of Oak Forest, have residents complaining about the bright lights glaring in their homes at night.

encourages residents to recycle their live Christmas trees instead of tossing them in the garbage. This holiday season, help the City preserve the environment and repurpose your live tree into mulch (or other landscape materials) by dropping off your tree at any of the

23 drop-off locations provided by the City of Houston Solid Waste Management. Trees may be dropped off until January 26, 2024. The drop-off location nearest Shepherd Forest is **TC JESTER PARK located at 4200 West TC Jester.** Make sure to



remove all decorations, tinsel, plastic bags, tree stands and water bowls before dropping off your tree. A complete list of Christmas tree recycling drop-off centers is available at <u>http://houstontx.gov/solidwaste</u> or by calling the City of Houston Helpline at 311.

SECURITY/CITIZENS ON PATROL NEWS

Suspicious vehicles and people wandering through the neighborhood were reported several times during the holidays. Please remember to stay alert to everything going on around you, and make a mental or written note of descriptions of vehicles and people that seem suspicious to you. Security Coordinator Paul Berry also reminds us that it's extremely important for residents to **report ALL CRIME** to HPD, regardless of how insignificant it may seem. The number of HPD patrol units assigned to our area is based on the number of calls to HPD we make. HPD also encourages residents to report suspicious people/activity so they will know what is going on in our neighborhood and then also notify our Security Coordinator at 915-373-8820 and report what has happened. GARBAGE NEWS

Here's the scoop on garbage and recycle collection. If you live in **Sections 1 or Section 2 (both are EAST of TC Jester),** your household weekly garbage pickup day is on **Tuesday.** Your curbside Recycling is every other **Tuesday** and heavy trash is on the **third Thursday** of each month.

If you live in Section 3 (WEST of TC Jester), your household weekly garbage pickup day is on Thursday. Your curbside Recycling is every other Thursday and heavy trash is on the fourth Tuesday of each month.
