
Get Involved – The Future of Shepherd Forest Depends on it

Citizens Patrol Security Report

Reported crimes in Shepherd Forest were down again since last month, but alert neighbors have been reporting any and all kinds of suspicious activity on social media. Thanks to Facebook, Twitter and NextDoor, we can all be aware and prepared when something out of the ordinary is happening on our streets.

Here's what has been reported since the last newsletter:

7/19/16	Sec. 1	900 block 31 st	– Vagrant observed walking slowly through the neighborhood

No matter how minor something might seem, please take a moment to report it to HPD. You can do this easily on line at http://www.houstontx.gov/police/online_report.htm. Then go to the Shepherd Forest Facebook page and share the information there, and/or www.Nextdoor.com to let your neighbors know that this is happening on your street or in your section.

Citizens Patrol reminds us to **call HPD (911 if it is an emergency, or 713-884-3131) if you should see anything or anyone that appears to be “suspicious,”** regardless of how insignificant it may seem. Then, **AFTER** you have made the call to HPD, notify our Citizens Patrol by reporting it to our new COP Coordinator Debby Fisher 281-221-6222.

It's the Law – City Ordinances You Should Know ...

Sec. 6-3 -- Permitting a domestic animal (dog or cat) to run at large

Sec. 10-341(c) -- Failing to **remove a vehicle or boat** from a property this is **inoperable**

Sec. 10-344(a) -- Failure to keep premises free of **garbage**

Sec. 10-213(a) – Failure to **post address** of residence within 18 inches of front door

Sec 39-77 (d) -- Placing **heavy trash** curbside prior to the Friday preceding collection

Sec. 10-452(b) (10) – Permitting grass and weeds to grow in **excess of 9 inches**

If you observe any of these violations, you can report them (anonymously, if you prefer) by calling **311** (the city of Houston's Non-Emergency City Service source). You can also file a report on their website for more information (www.houstontx.gov/311) to read about the many different ways the City is prepared to help. If you use a smart phone, there is also a 311 app that allows you to upload pictures of the violations you take with your phone.

Ask An Attorney ...

Motor vehicles and parking issues can lead to disputes between neighbors, so this month's column is a general review of the City of Houston's parking ordinances.

Use your common sense - even if there is no well-defined curb on a street, one is not allowed to park on or block a sidewalk. Drivers are not allowed to block private driveways, park in school zones, bus zones or within 15 feet of a fire hydrant. One must park his or her vehicle within 18 inches of the right-hand curb; do not park on the "wrong" side of the street.

The City of Houston mandates that no car should be parked on a street more than 24 hours at a time. Trailers or semi-trailers may not park on the street for more than two hours. Commercial vehicles may not park on the street between 2:00 a.m. and 6:00 a.m. Do not obstruct the street or park within 20 feet of a cross-walk intersection. If you get a ticket, you may pay or contest the citation at <http://www.houstontx.gov/parking/resolve.html>. However, simplest way to prevent a parking citation and be a good neighbor is to follow these basic rules.

Section 1 – 1018 Stonecrest – The Gutierrez family. This eye-catching yard is almost a landmark in Section 1. Lots of everything here – caladiums, ferns, knockout roses, and yard art everywhere you look.
