# Citizens Patrol Security Report

Our annual uptick in crime has arrived ... Last June we reported here a record number of crimes – mostly thefts of tailgates and the contents of cars. Not quite as many incidents as last June's report, but more than an acceptable number.

Here's what has been reported since the last newsletter:

6/5/17	Sec 1	1500 block Stonecrest – cars entered and small items taken
6/7/17	Sec 1	1400 block Stonecrest – cars broken into – HPD arrested 2 perpetrators

6/8/17	Sec 1	1400 block Stonecrest – Theft
6/11/17	Sec 1	900 block 31 <sup>st</sup> – A/C condenser unit stolen from house

Then go to the Shepherd Forest Facebook page and share the information there, and/or [www.Nextdoor.com](http://www.Nextdoor.com) to let your neighbors know that this is happening on your street or in your section. Citizens Patrol reminds us to **call HPD (911 if it is an emergency, or 713-884-3131) if you should see anything or anyone that appears to be "suspicious,"** AFTER you have made the call to HPD, notify our Citizens Patrol by reporting it to our new COP Coordinator Debby Fisher 434-221-6222.

## ***Precinct 1 Constable Alan Rosen suggests ...***

It is a fact that law enforcement sees an uptick in property crimes when the weather gets warmer. Crooks can move around more comfortably after the cold season recedes. Youthful lawbreakers have more time on their hands when school is on a break. And in the summer, residents are less suspicious when they see a teen around during weekday hours. The neighborhood crime that our patrol deputies come across most frequently is the nighttime burglary of parked cars and trucks. In the dark, when they are less likely to be seen, thieves pull on door handles to see which ones are unlocked. Or they bash through vehicle windows using a heavy tool such as a tire iron. Once inside they grab cash, coins and wallets, or anything re-sellable such as computers, cell phones, jewelry, athletic equipment, etc.

But there are ways to drastically reduce the chance that your vehicle is the next target. Some of the actions are so simple that you might think every vehicle owner does them. But if that were true, the thieves would have moved on to another urban area long ago.

**Lock your vehicle doors,** You'd be surprised how many people don't. Locking your doors may cause a criminal to sneak to the next car or truck in the search for something to steal.

**Park in a well-lit area, preferably your driveway.** Crooks would rather work in the shadows, away from people who might hear them.

When you are not in your vehicle, **hide valuables in the trunk or remove them.** A purse, phone, coat, briefcase or even loose change left in plain sight makes your car or truck a lure to the bad guys. They want to commit a crime of opportunity – you want to remove the opportunity.

These steps cost nothing. But you can also invest in prevention. Vehicle alarm systems, driveway gates and easily-noticed residential security cameras can all reduce these common crimes. Also there are kits that truck owners can buy to make their vehicle tailgates harder to remove. Many rims and hubcaps can be locked too.
