

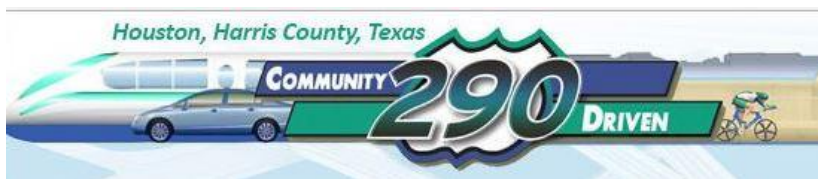

right now, and on Monday night we will get an update from **TxDOT project superintendent Mike Zientek** as he returns to our general meeting to give us a status report and some new estimates on the time line.

Zientek, an Oak Forest resident for over 10 years, feels your pain. He also travels through the area on a daily basis, so he fully understands where the street-level frustrations lie. "We understand the profess is frustrating" he told The Leader Newspaper, "but once its completed it will be so much better with all the pieces that will be opened up." # Citizens Patrol Security Report

Thefts and burglaries continue to be part of our report this month. The all-too-common disappearance of packages from porches and front doors appears prominently in recent crime reports from HPD and SpotCrime. Our parked vehicles were also vulnerable to break-ins, although theft from unlocked vehicles was more common. Several instances of “suspicious activities by non-residents” in the area have been reported directly to the Civic Club. If you do not have a garage to lock your car in, PLEASE LOCK YOUR VEHICLES AT ALL TIMES. Don't leave temptation (ladders or tools) in the bed of your pickups. HPD recommends ALWAYS locking your car, and never leave valuables in the car.

During the December Civic Club Board of Directors meeting, it was discussed and decided that security in all three sections of Shepherd Forest merited closer scrutiny. Vice President Patricia Williams volunteered to organize a meeting of all interested residents for the purpose of organizing a “Security Team”.

The Security Task Force will be making recommendations to the board and officers concerning specific ways security should be enhanced in Shepherd Forest. The first meeting will cover the basic goals: developing recommendations to make to the Civic Club; brainstorm some possible solutions; and set a time/date for future meetings. Also at this meeting, James Alexander, Director of Operations at S.E.A.L., will give us a 20 minute presentation on what they offer and the cost.

The first meeting will be held on **Monday, January 22, at St. Stephen's United Methodist Church at 7:00 p.m.** St. Stephen's is located at 2003 West 43rd. Exact location of the meeting will be determined based on the number of participants who express and interest in attending.

According to Ms. Williams, “Right now, we have Citizens on Patrol (COP), and we deeply appreciate what they have done over the years to help Shepherd Forest. But questions remain: Should we beef up security, and if so, how much would the endeavor cost? Should we hire a company or the Constable's office? What would we receive for our money? How should we fund any initiative? Hope to see you there!”

## Safe Passage for Pedestrians on Alba

*(from Jennifer Woodruff, past President of the SF Civic Club)* If you live in section 1, east of Ella, you have likely driven down Alba. But have you tried to walk it? Many of us on foot in section 1 put our lives at risk as we try to dodge cars and reckless drivers who cut through on Alba to avoid the traffic light at 34th and Ella.

I personally have almost been hit (on more than one occasion) by Alba drivers as I jog with my dog - on the street - because there is no sidewalk for safe pedestrian access. Most recently i witnessed a couple with their baby in a stroller almost get hit by a driver on Alba as they walked from the Slowpokes parking lot back into the neighborhood. That was the "enough is enough" moment. The next day I called Ellen Cohen's office to find out what action could be taken. Here's what I learned:

The city has a Safe Sidewalk Program, however, the waiting list is 3-5 years with no guarantees of project acceptance and frankly our odds sounded bleak. So, after discussing it further with Cohen's office, who worked with Centerpoint on our behalf, it appears our best option is to self-fund the sidewalk (starting at 31st and connecting with the Gardendale sidewalk) as a community.

The path forward includes meeting with paving contractors, getting estimates and conducting a fundraising campaign to pull permits and implement the sidewalk plan. It's an ambitious project, but with your support and the support of our local business partners, we can make this happen and provide safe access to schools and all the new pedestrian-friendly developments coming to 34th street.

The Texas State Primary Elections will be held on March 6, 2018. Whether you plan to vote in person or by mail-in ballot, here are some key dates to remember:

**February 5** – Last day to register to vote for the primary

**February 20** – Early voting begins

**March 2** – Last day of early voting

**March 6** – Primary Election Day

**May 22** – Primary run-off elections
